JOB DESCRIPTION

Kin On is seeking a Part-time Weekend Activity Assistant, who works on Saturday and Sunday, reports directly to the Life Enrichment (Activity) Supervisor. The role is to assist the Life Enrichment (Activity) Supervisor to plan and organize programs, coordinate facility-wide events and volunteer services, and work within a team to meet resident's therapeutic needs and recreational interests.

ROLE AND RESPONSIBILITIES

The essential responsibility of the role is to help plan and organize programs for residents that maximize quality of life by meeting mental, physical, social and spiritual needs, which may include providing entertainment, exercise, relaxation and educational programs.

- Coordinate facility-wide events, intergenerational programs and volunteer services
- Develop and maintain strong resident/family relations and effectively deals with complaints to ensure a high level of customer satisfaction
- Assure completion of documentation and paperwork in a timely manner as assigned
- Post daily resident attendance records and maintain documentation as required by State and Federal regulations
- Support the facility's compliance with all state, local and federal regulations, HIPPA, OSHA , Fire code and Resident's Bill of Rights at all times
- Handle all forms of resident Protected Health Information (PHI) in a confidential, private and secure manner
- Other job-related duties as assigned.

MINIMUM QUALIFICATIONS

- Work on Saturday and Sunday a must
- English written and verbal ability a must. Chinese: Mandarin, Cantonese and Toishanese dialects also spoken a plus
- High school or GED equivalent. An A.A. degree graduated preferred
- Nursing Home, Assisted Living or senior care facilities experience preferred
- Proficiency in computer programs such as Microsoft Office Suite a must

WORK ENVIRONMENT

The role interacts with internal staff & departments, residents, family and friends on a daily basis. There will also be support for outdoor activities. Work is normally inside an elderly and vulnerable community setting; therefore ideal candidate will need to have patience, compassion and tolerance for the population at hand. Depending on the project requirement at times there will be time spent performing office work and other times a lot of walking around campus. A common day will have both settings.

PHYSICAL REQUIREMENT

The role requires standing, sitting, walking, pushing, pulling, ascending and descending stairways, full range of motion, occasional squatting, ability to lift weight up to 25-50lbs with hands and roll residents with wheelchairs around the facility and beyond. Ability to verbally yell, warn and direct in case of emergency, corrected vision and hearing, and sense of touch is required.
